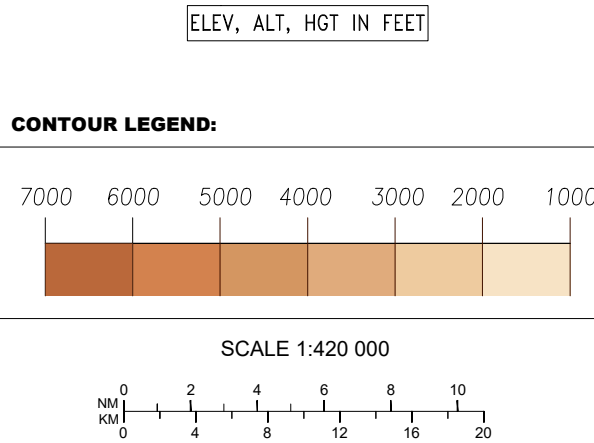


VFR CHART

- For VRP details and coordinates, refer Chart ENR 6-6.2.
- For Local VFR Regulations, see OMDb, OMDW, OMFJ, OMRK and OMSJ AD 2.20.
- For DUBAI CTA VFR/VRP, refer Charts ENR 6-4.1 and ENR 6-4.2.
- For DUBAI CREEK VFR/VRP, refer Chart OMDb AD 2-91.

- In case of EMERG pilots may squawk Mode A Code 7700 and contact:
 - In MBZ - Jazirah, RAS AL KHAIMAH TWR (118.250 MHz).
 - In MBZ 2 - Jumeirah (A, B, C), MINHAD APP (122.500 MHz).
 - In MBZ 3 - North (A, B, C), DUBAI DEP NORTH (124.675 MHz).
- VFR traffic operating in uncontrolled airspace under the extended runway centrelines of OMDb, OMDW, OMFJ, OMRK, and OMSJ airports must exercise caution due to potential wake turbulence.
- VFR traffic shall obtain ATC clearance before entering controlled airspace and are to remain clear of controlled airspace until ATC clearance is obtained.
- To obtain ATC clearance for entry into AL MAKTOUM, DUBAI, FUJAIRAH, RAS AL KHAIMAH, or SHARJAH CTR, VFR traffic shall contact the respective Tower.
- To obtain ATC clearance for entry into controlled airspace (Class C or D) of DUBAI, RAS AL KHAIMAH, or FUJAIRAH CTA, VFR traffic shall contact the applicable ATC Unit as specified in ENR 2.1.
- VFR traffic must strictly comply with the ATC clearance limit and are not permitted to proceed beyond the specified limit.
- VFR traffic intending to transit OMR 75 shall contact MINHAD APP (122.500 MHz) for approval. Transit may be restricted.
- VFR traffic intending to transit TRAINING AREA 008 shall contact DUBAI SOUTH RADAR (120.400 MHz) before entering to obtain the status of the training area. Transit may be restricted.
